The Millennium Challenge Corporation ("MCC") and the Government of Liberia (the "Government" or "GoL") have entered into a Millennium Challenge Compact for Millennium Challenge Account assistance to help facilitate poverty reduction through economic growth in Liberia (the "Compact") in the amount of approximately 256,726,000 USD ("MCC Funding"). The Government, acting through Millennium Challenge Account - Liberia ("MCA Entity" or "Purchaser"), intends to apply a portion of the MCC Funding to eligible payments under a contract for which this Request for Quotations ("RFQ") is issued. Any payments made under the proposed contract will be subject, in all respects, to the terms and conditions of the Compact and related documents, including restrictions on the use of MCC funding and conditions to the disbursements of MCC funding. No party other than the Government and the Purchaser shall derive any rights from the Compact or have any claim to the proceeds of MCC Funding. The Compact and its related documents can be found on the MCC website ([www.mcc.gov](http://www.mcc.gov)) and on the website of the MCA Entity.
2. You are invited to submit your price quotation for the **Supply of Spare Parts for Liberia Electricity Corporation (LEC) Bushrod Island 18 MW Thermal Power Plant.**

4. You are invited to quote for all items in accordance with the format contained in this RFQ. Failure to quote for all items in the required format will render your quotation incomplete and thus non-responsive.
5. The deadline for submission of your quotation is: **August 23, 2018 at 4:00 pm** Liberia time in the format provided in **Annex 2** of the complete RFQ, which is available at the address indicated in item 13 below.
6. Request for clarification may be sent to the email address indicated in item 13, below, no later than August 10, 2018. MCA-Liberia shall respond by end of day August 14, 2018.
7. Evaluation of offers and award of purchase order:

Offers determined to be substantially responsive to the technical requirements of the goods will be evaluated by comparison of quoted prices in accordance with MCC Program Procurement Guidelines. A Purchase Order Agreement will be issued to the Supplier offering the total lowest evaluated quotation price and meets the technical requirements of the required goods for all items.

8. The Purchase Order Agreement terms and conditions are not negotiable and shall be fully accepted by the Supplier.
9. You must clearly state the **Model of the Goods, Country of Origin, warranty and guarantee conditions/duration** for the goods proposed. The proposed goods must have a minimum **Guaranty of one-year**.
10. You must clearly state the **Guarantee Conditions/Period for Replacement** of defective Goods (no later than thirty (30) calendar days after the contract manager notifies the defects).
11. Bid Challenges. Suppliers may challenge the results of this procurement only according to the rules established in the Bid Challenge System developed by the MCA-Liberia and approved by MCC. The rules and provisions of the Bid Challenge System are as published on the MCA-Liberia's website at [www.mca.gov.lr](http://www.mca.gov.lr).
12. The Purchaser is not bound to accept any quotation submitted by the invited Suppliers and may cancel the procurement process at any time without providing any justification to the Suppliers.
